NCCB Board Meeting by Zoom called to order at 9:47 am by Vice President Paul Furman

QUORUM: Shelley Niehaus stated that a quorum was met.

MINUTES: Motion was made to accept minutes of the September 26, 2020 board meeting by Nancy Furman and seconded by J Craig Lilly. All approved.
